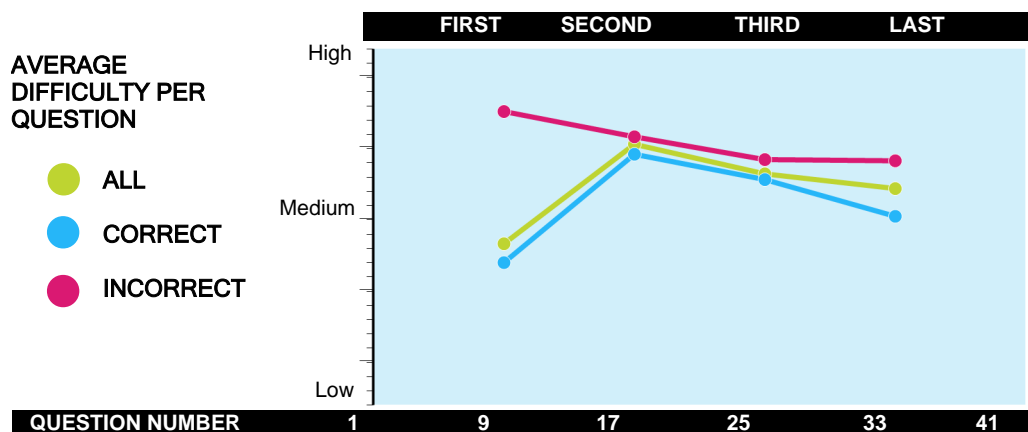

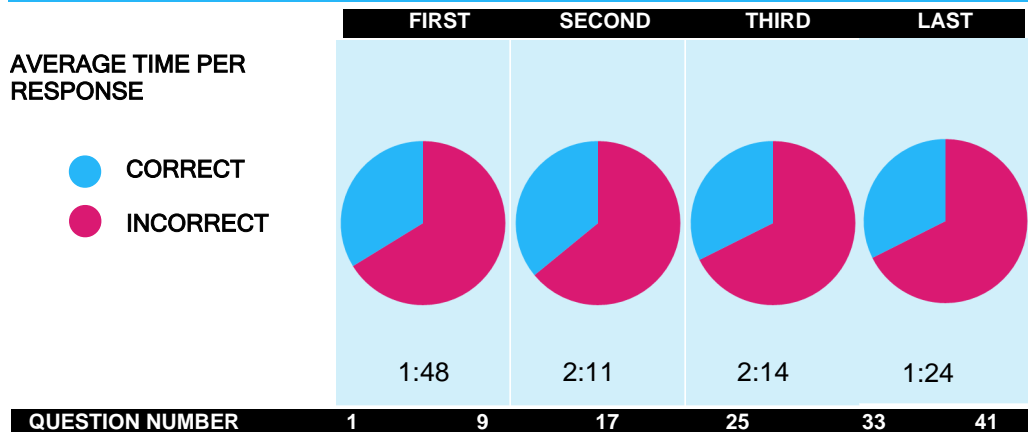

PERFORMANCE OVER TIME



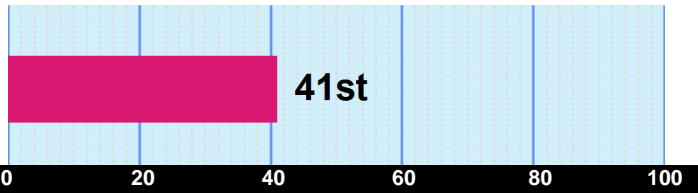

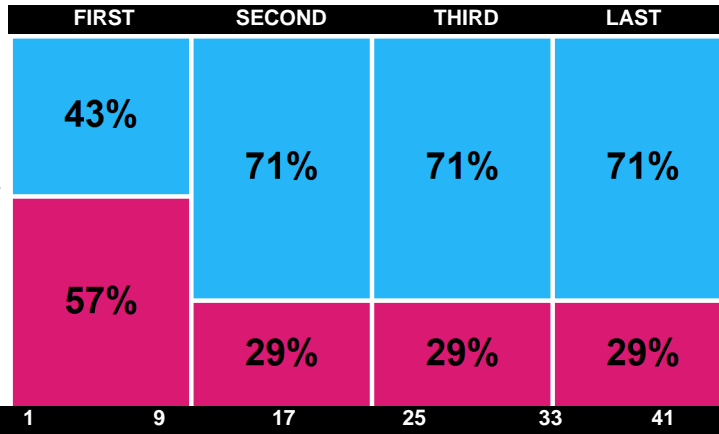

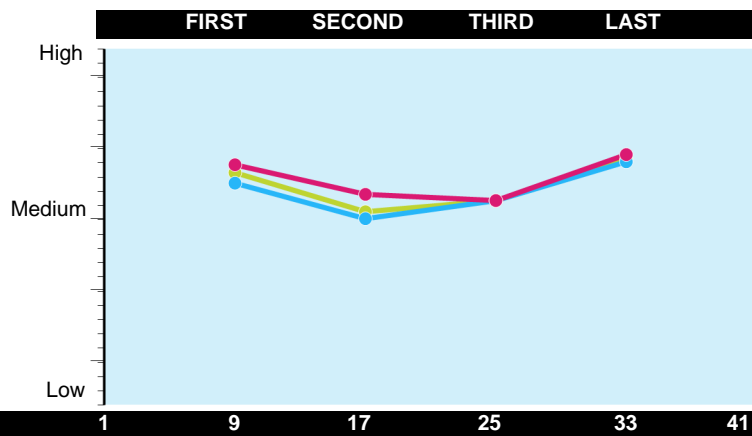

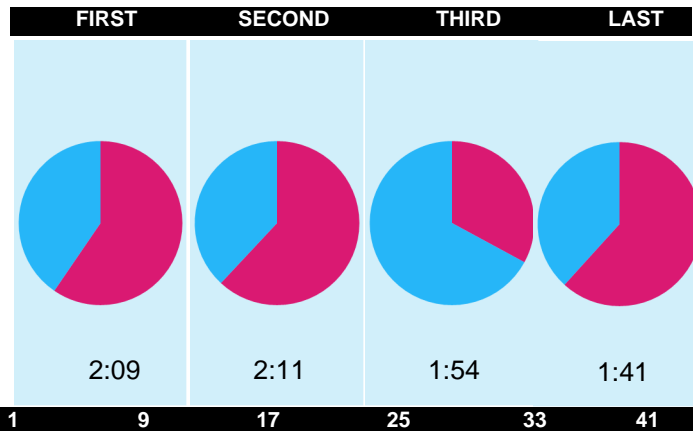
