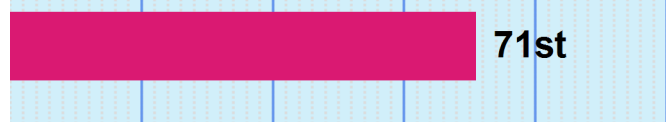

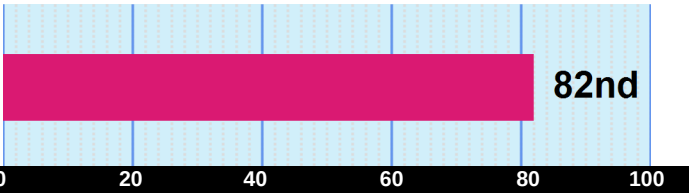

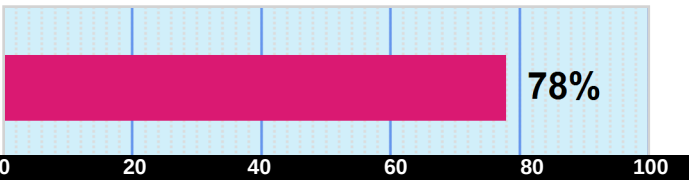

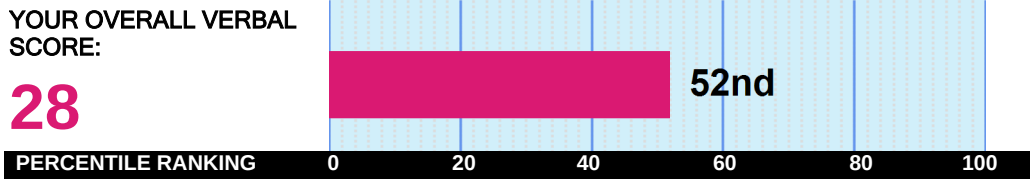

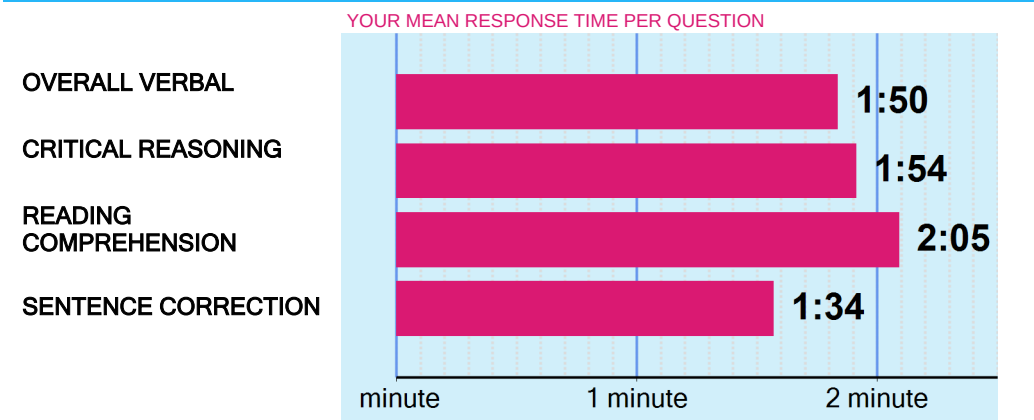
Verbal Section Performance



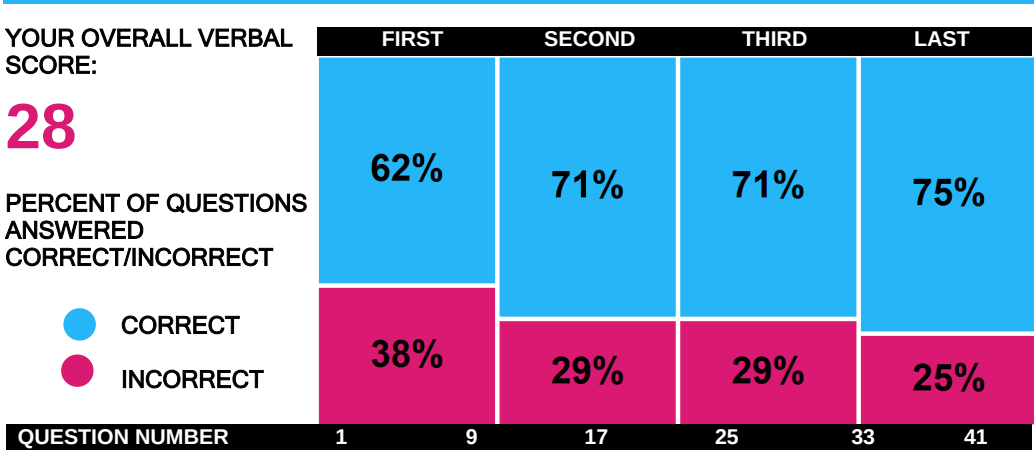

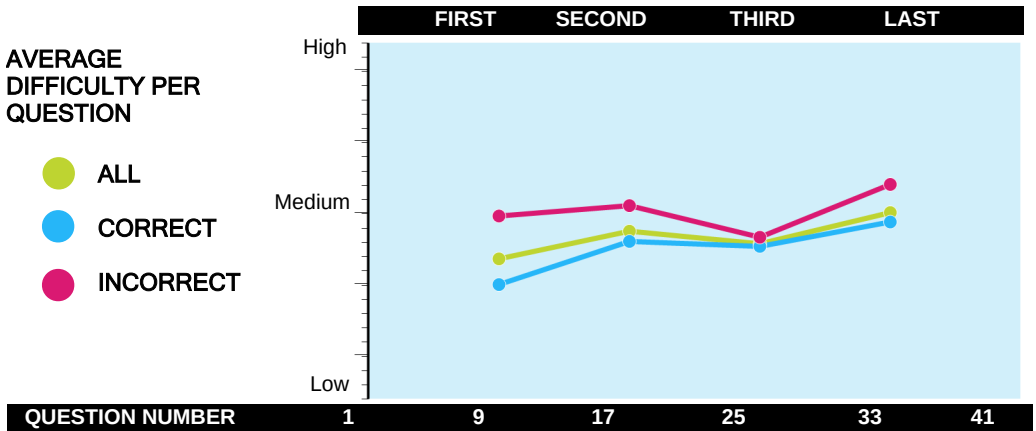

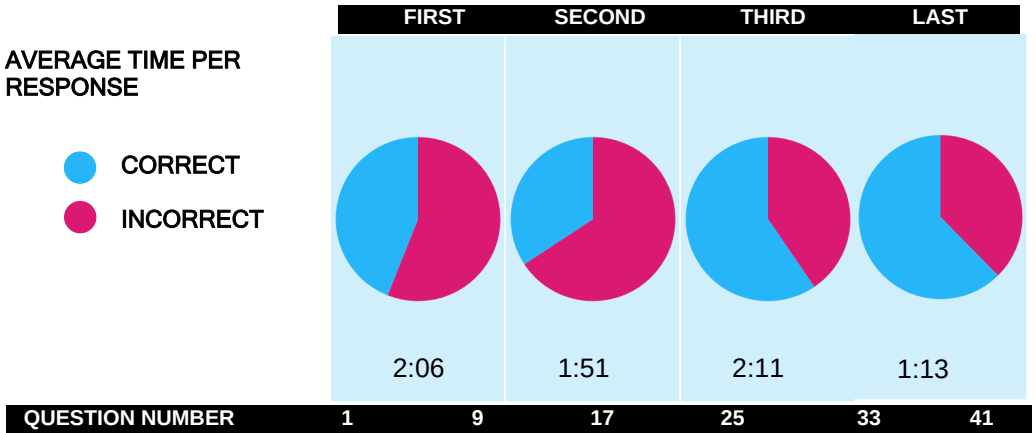

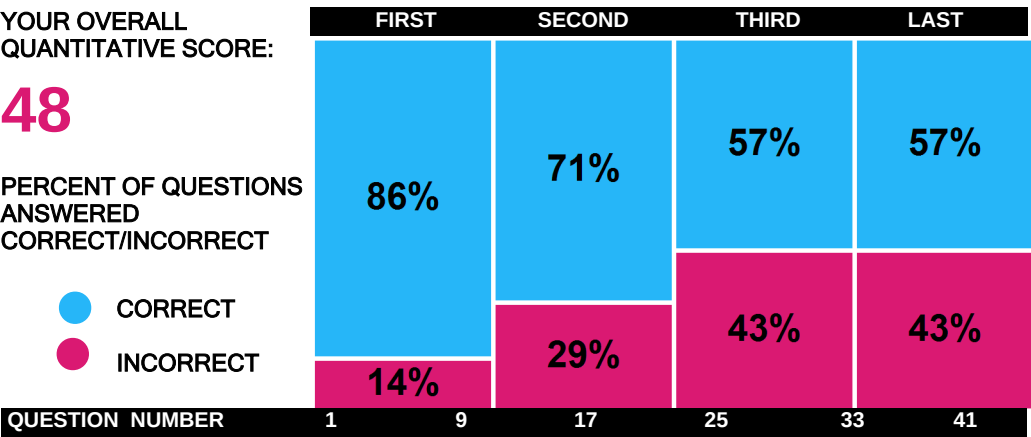
