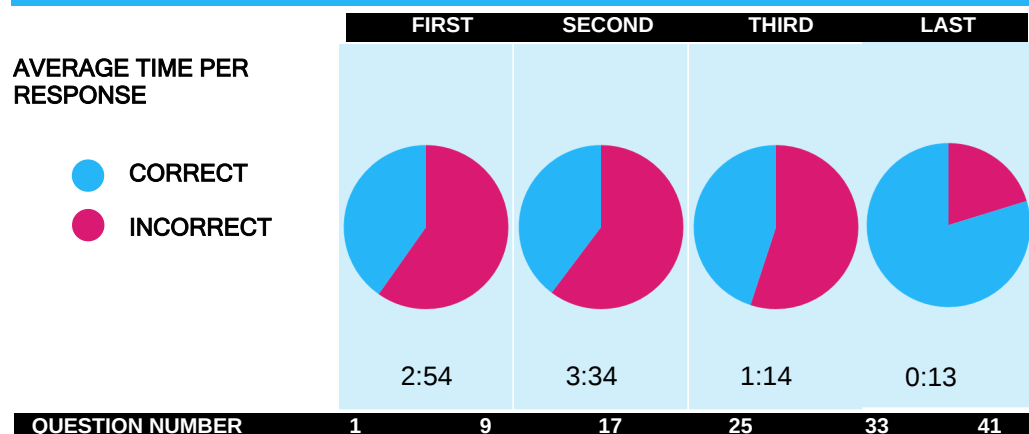

Quantitative Section Performance



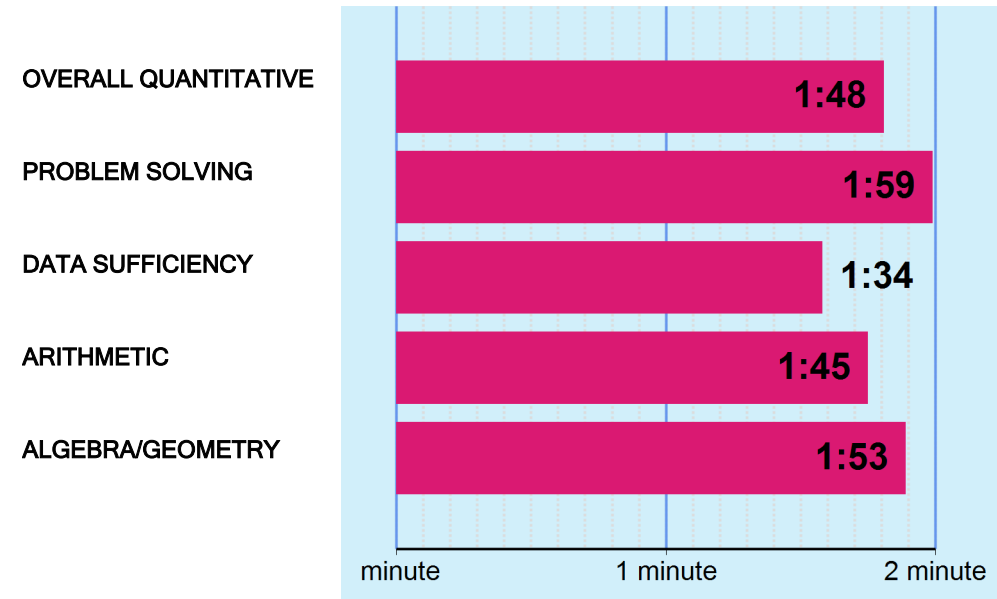
