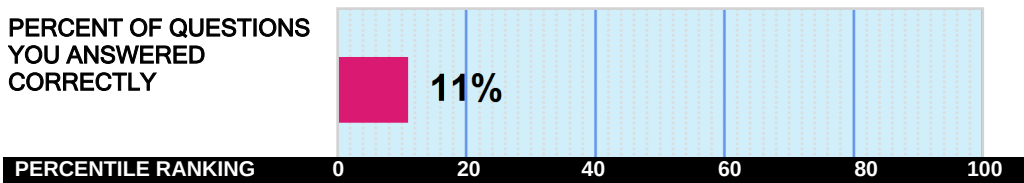

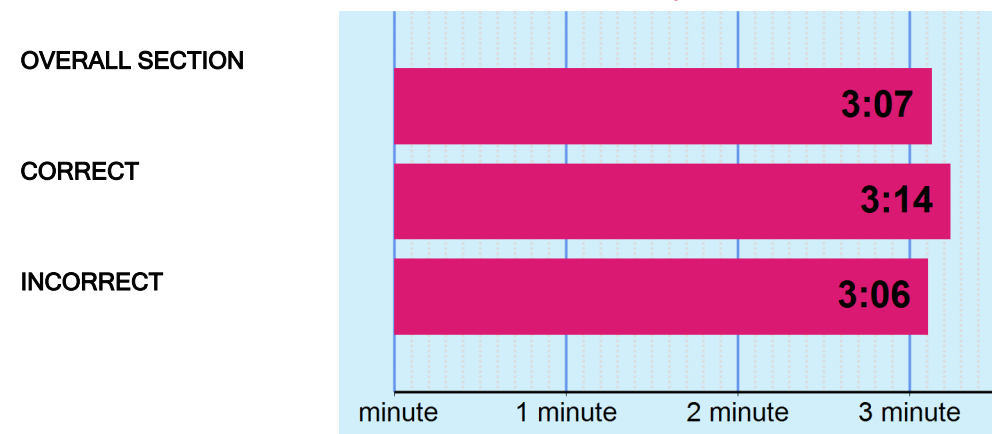

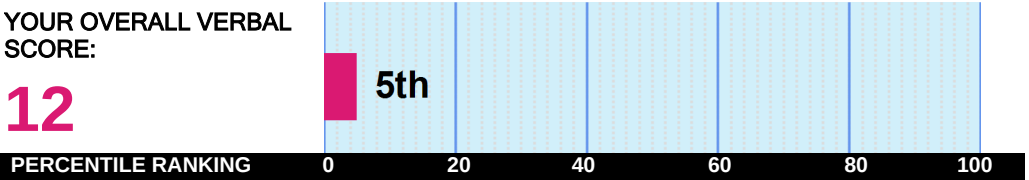

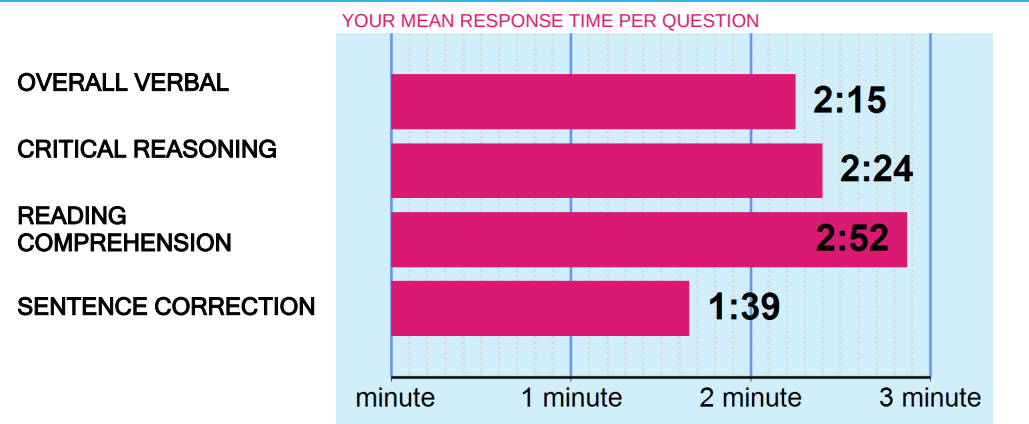
Verbal Section Performance



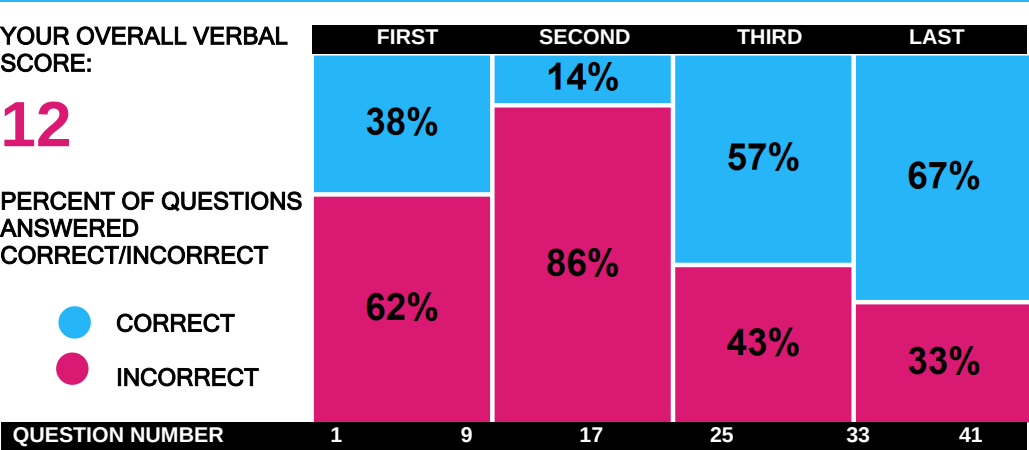

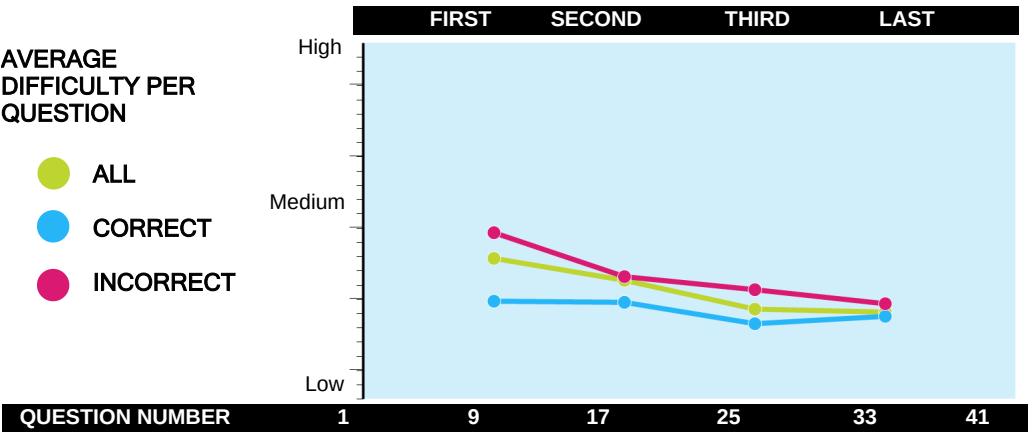

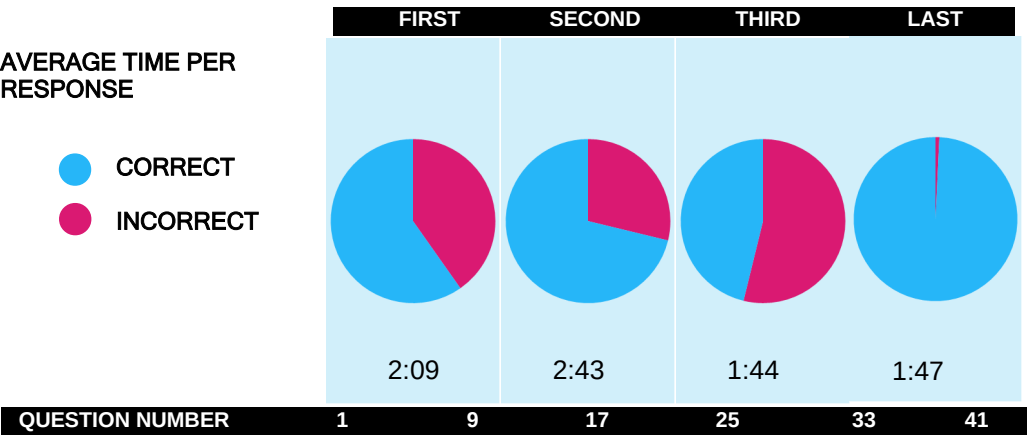
