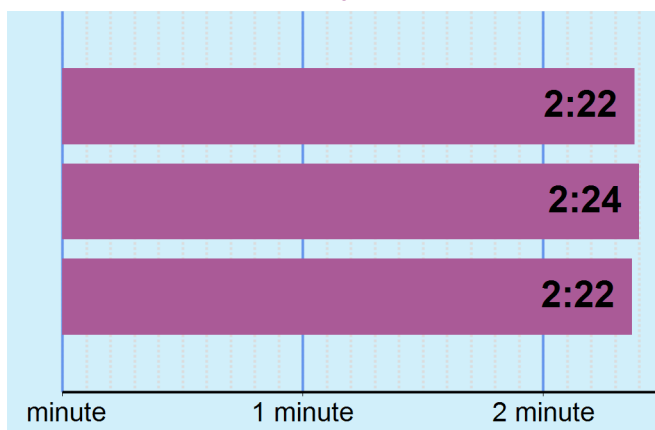

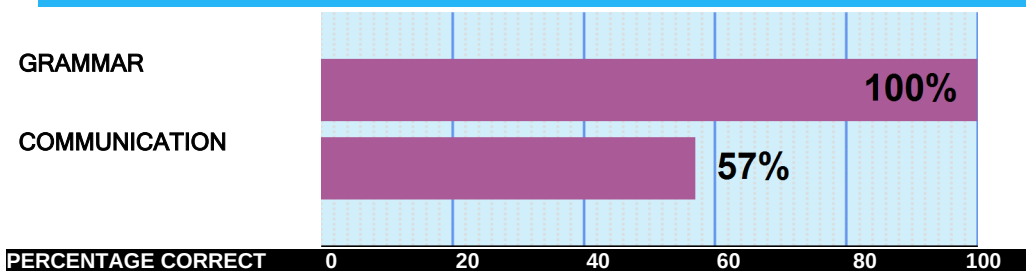

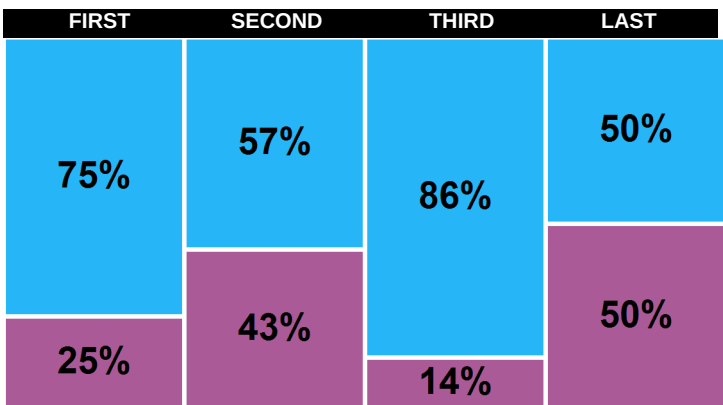

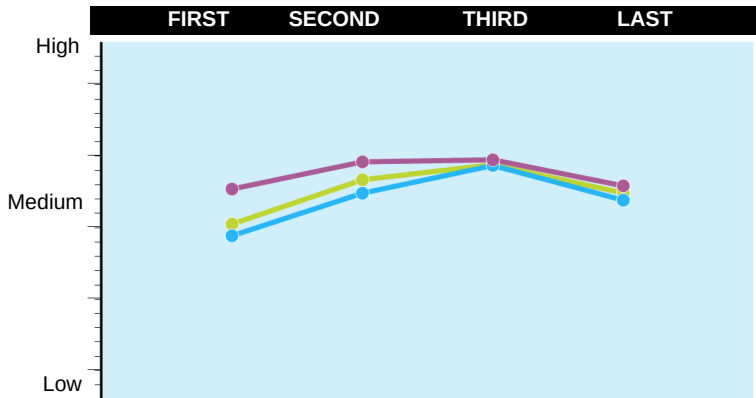

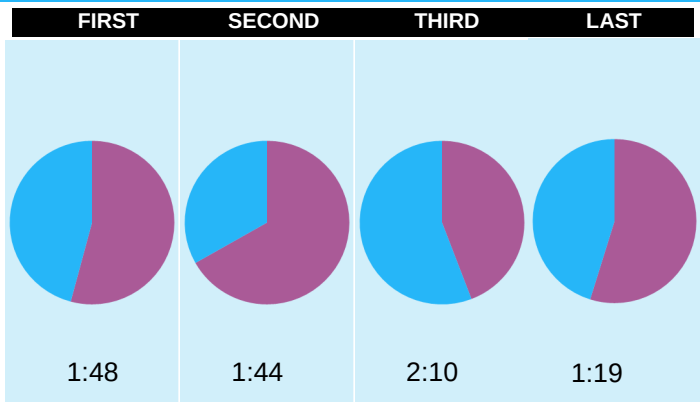

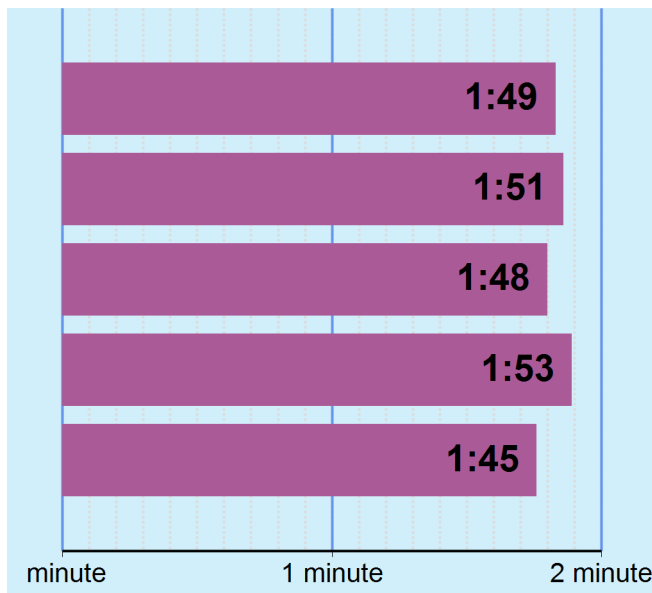

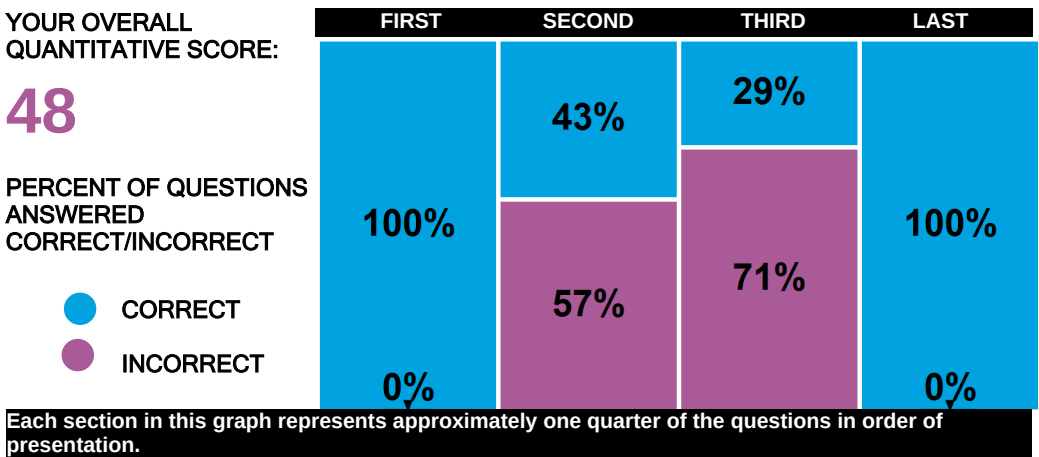

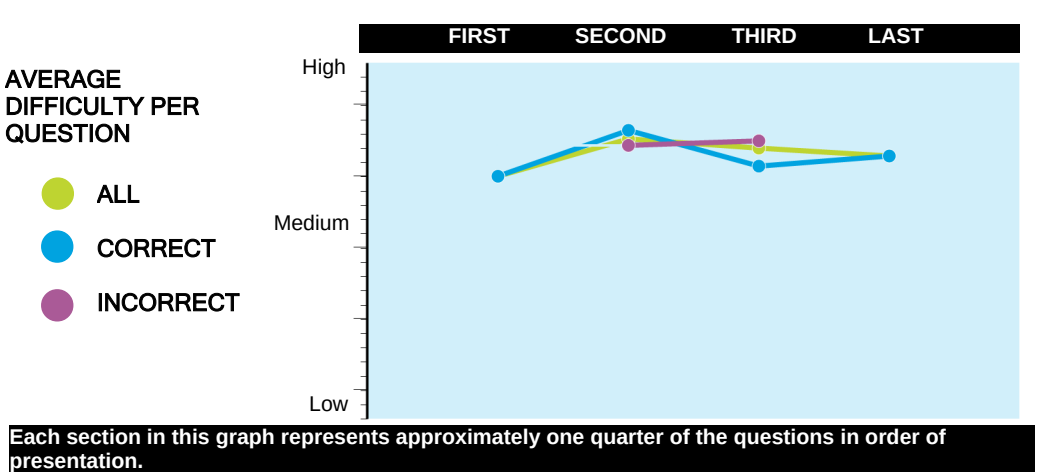
PERFORMANCE BY FUNDAMENTAL SKILLS

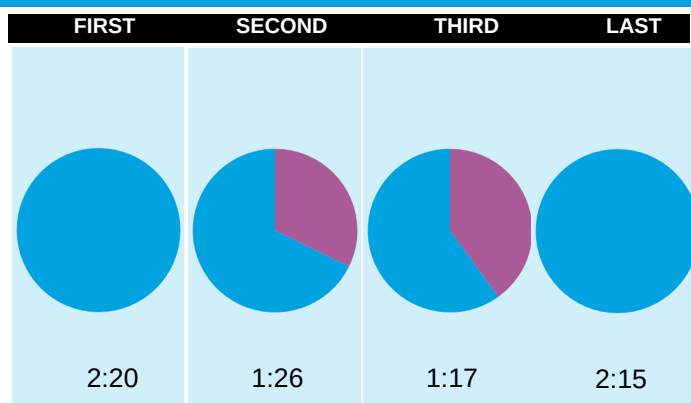
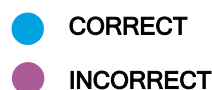
