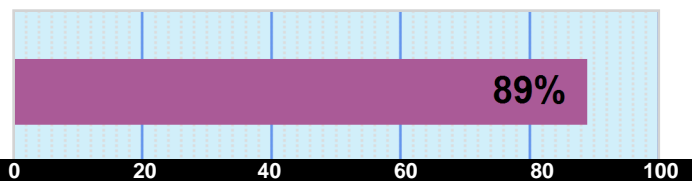

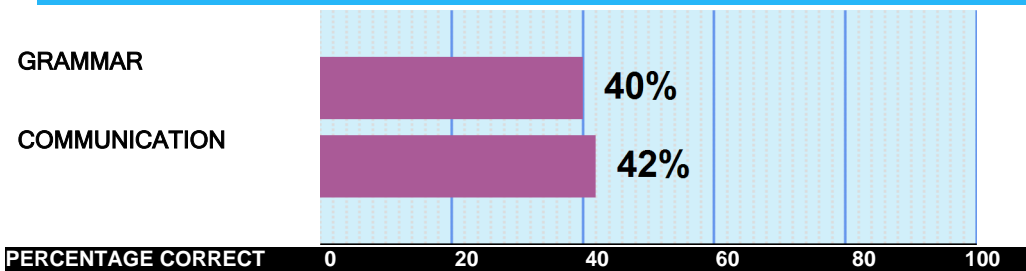

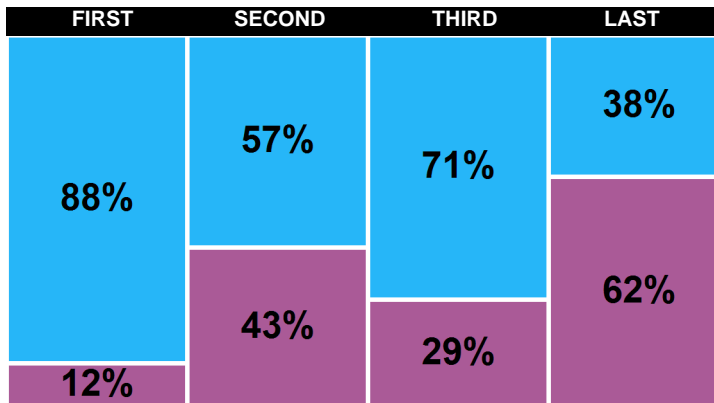

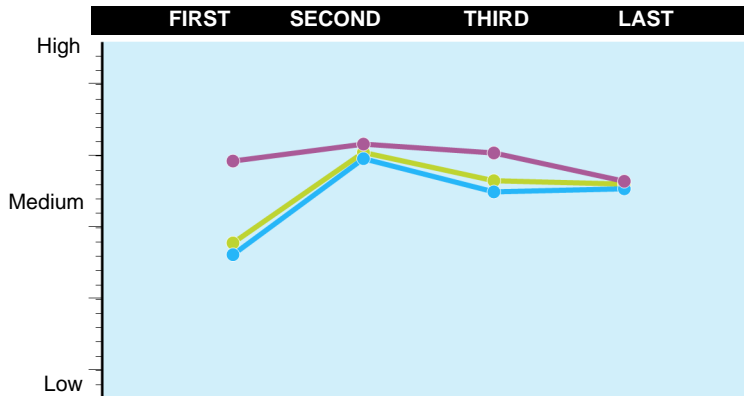

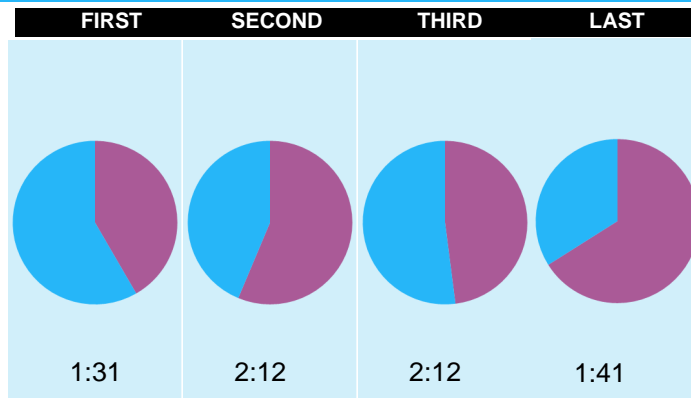

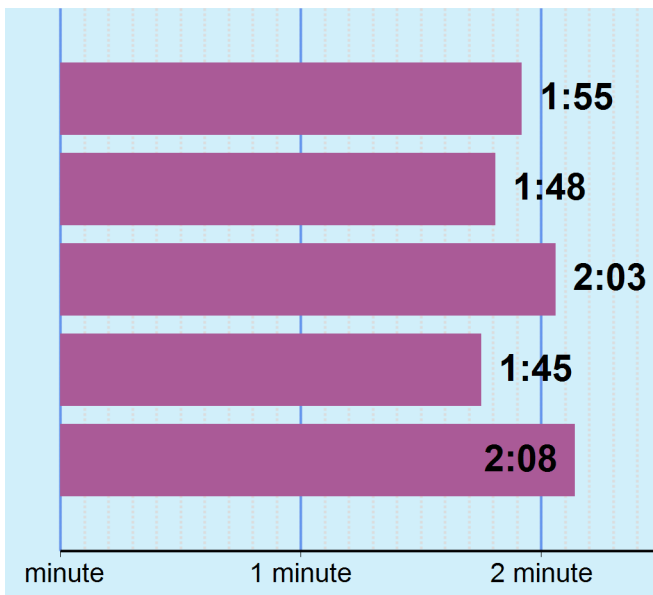

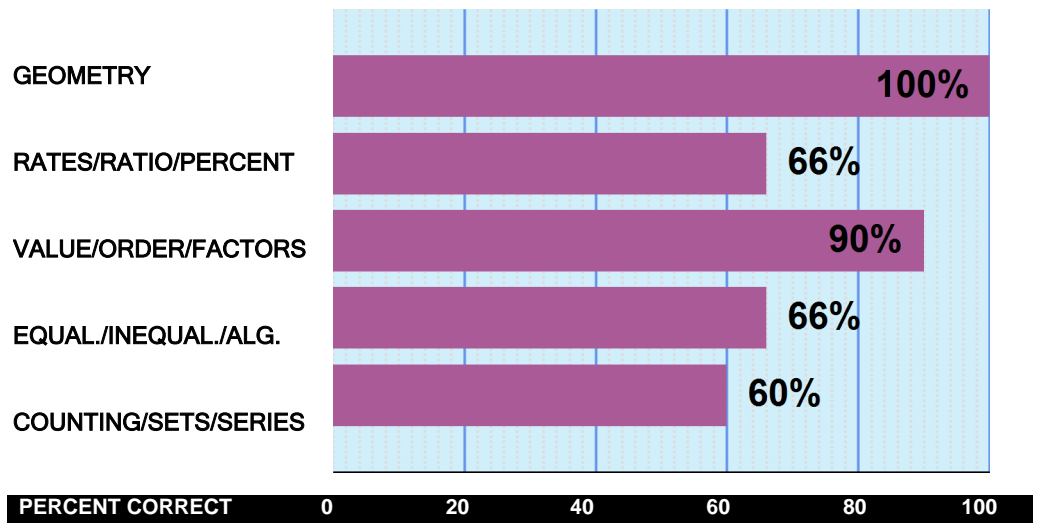

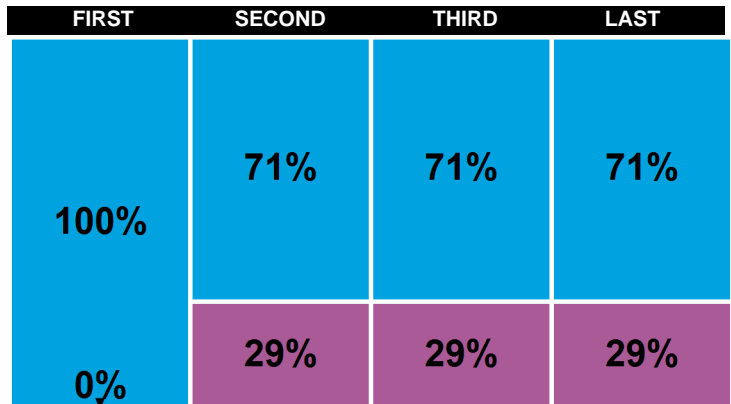

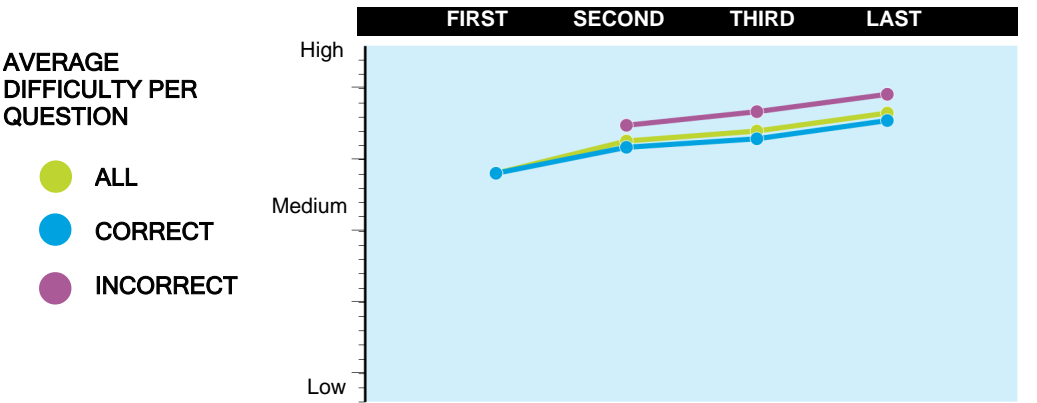

AVERAGE DIFFICULTY



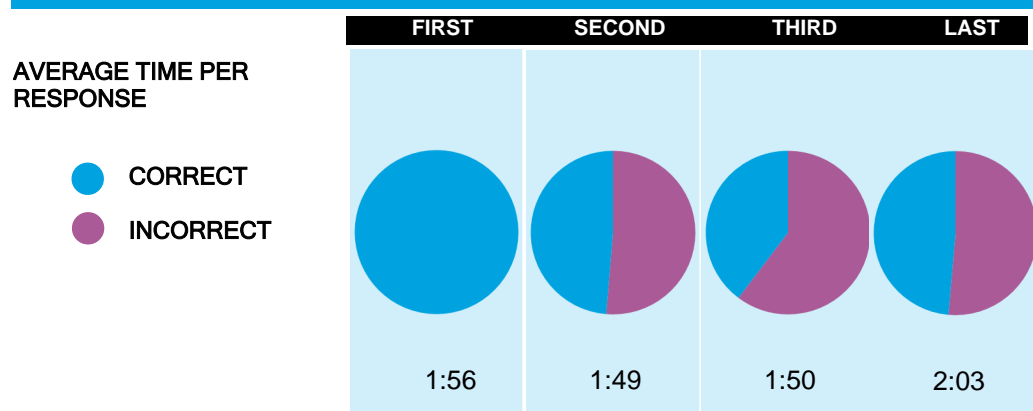
