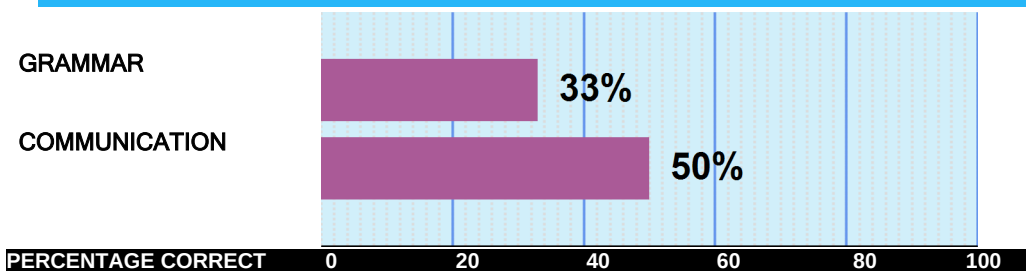

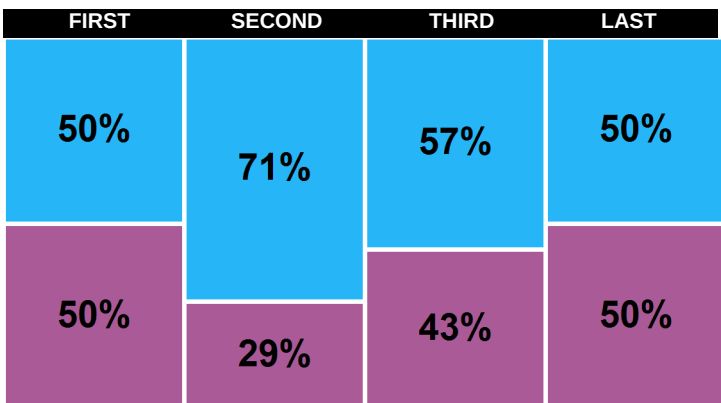

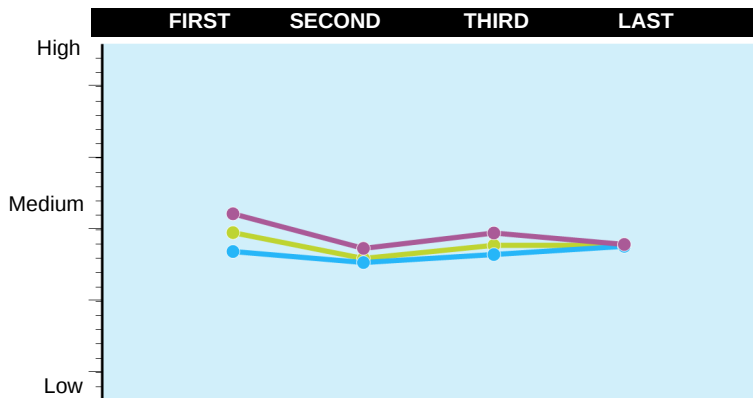

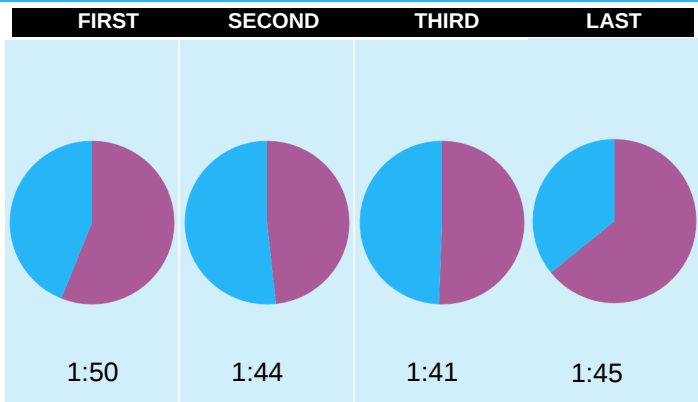

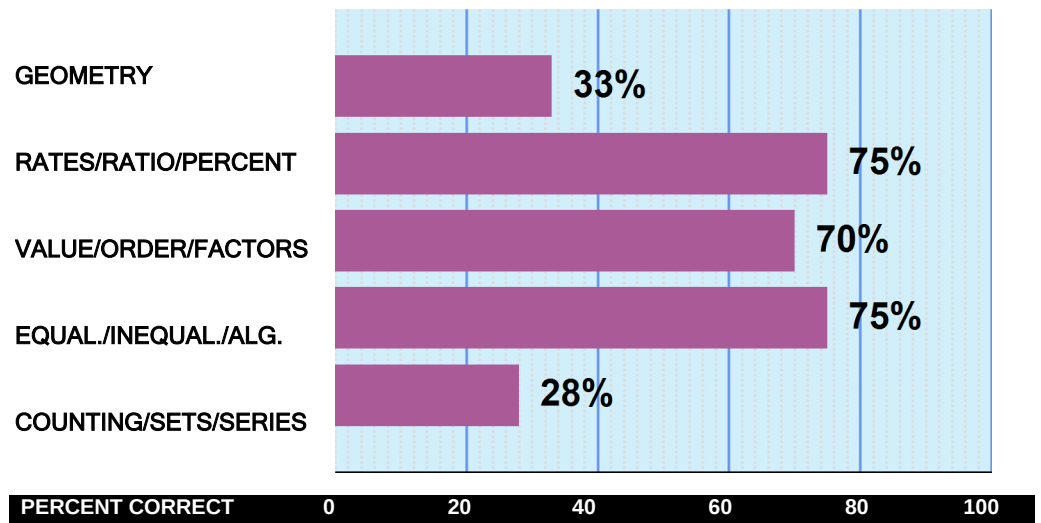

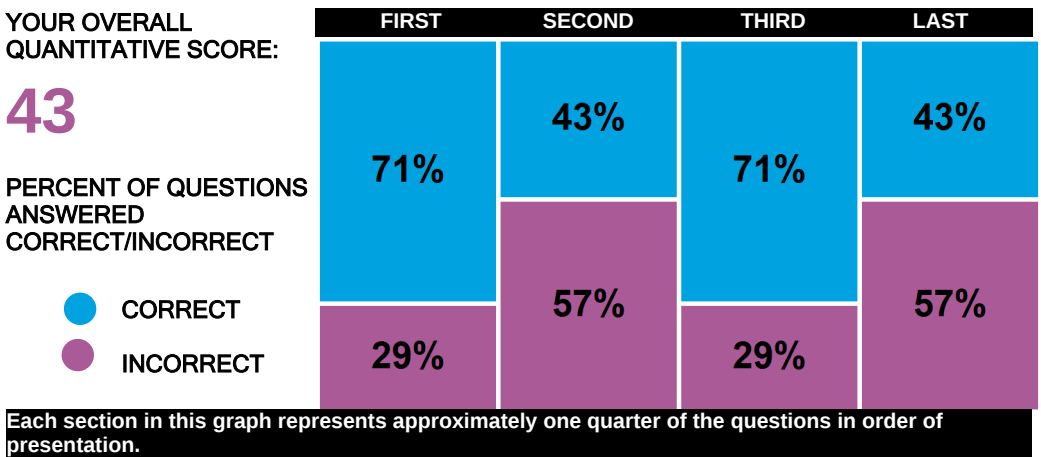

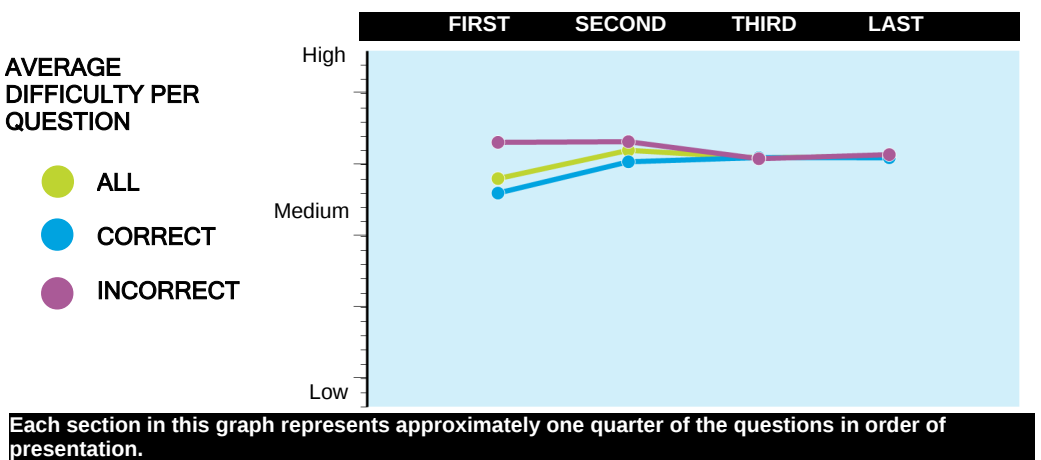
PERFORMANCE BY FUNDAMENTAL SKILLS

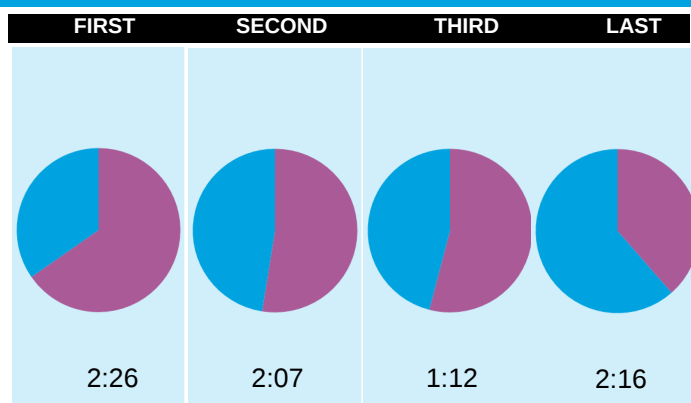
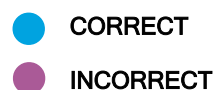
